ORDINANCE 2020-02

AN ORDINANCE LEVYING AD VALOREM TAXES FOR USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF SULLIVAN, TEXAS FOR THE 2020–2021 FISCAL YEAR; PROVIDING FOR APPORTIONING EACH LEVY FOR SPECIFIC PURPOSES; AND, PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN SAME SHALL BECOME DELINQUENT IF NOT PAID, PROVIDING FOR AN EFFECTIVE DATE WAIVING $2^{\rm ND}$ AND $3^{\rm RD}$ READING

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SULLIVAN CITY:

SECTION 1 That there is hereby levied and there shall be collected for the use and support of the municipal government of the City of Sullivan City for the 2020-2021 Fiscal Year, upon all property, real, personal, and mixed, within the corporate limits of said City subject to taxation, a tax of \$0.4838 on each \$100 valuation of property, said tax being so levied and apportioned to the specific purposes here set forth:

- 1. For the maintenance and support of general government (General Fund), \$0.4420 on each \$100 valuation of property; and
- 2. For the Interest and Sinking Fund to pay debt obligations, \$.0418 on each \$100 valuation of property; for a combined accumulative tax rate of \$.4838 on each \$100 valuation of property.

SECTION 2 That taxes levied under this ordinance shall be due October 1, 2020, and the period for the payment of taxes without penalty or interest shall be October 1, 2020 through January 31, 2021 and if not paid on or before January 31, 2021, shall immediately become delinquent.

SECTION 3 All taxes shall become a lien upon the property against which assessed, and the County tax collector of the County of Hidalgo is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and ordinances of the City of Sullivan City and shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and, the interest and penalty collected from such delinquent taxes shall be apportioned to the general fund of the City of Sullivan City. All delinquent taxes shall bear interest from date of delinquency at the rate as prescribed by state law.

SECTION 4 All taxes shall be payable at the office of the Hidalgo County Tax Assessor Collector in Hidalgo County, Texas and the period for the payment of taxes without penalty or interest shall be October 1, 2020 through January 31, 2021.

SECTION 5 This ordinance shall take effect and be in force from the date after its passage.

SECTION 6 Effective date: First Reading on the 29^{TH} day of September, 2020 passed by an affirmative vote of all members of the City Council of Sullivan City, waiving 2^{nd} and 3^{rd} reading by an affirmative vote of all members of the City Council of Sullivan City.

ORDINANCE 2020-03

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF SULLIVAN CITY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020, AND ENDING SEPTEMBER 30, 2021; AND ADOPTING THE ANNUAL BUDGET OF THE CITY OF SULLIVAN CITY FOR THE 2020-2021 FISCAL YEAR, WAIVING 2ND AND 3RD READING

Whereas, the budget, appended here as Exhibit A, for the fiscal year beginning October 1, 2020, and ending September 30, 2021, was duly presented to the City Council by Mayor Leonel "Leo" Garcia and a public hearing was ordered by the City Council and a public notice of said hearing was caused to be given by the City Council and said notice was published in City Hall and said public hearing was held according to said notice; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SULLIVAN CITY:

SECTION 1 That the appropriations for the fiscal year beginning October 1, 2020, and ending September 30, 2021, for the support of the general government of the City of Sullivan City, Texas be fixed and determined for said terms in accordance with the expenditures shown in the City's Fiscal Year 2020-2021 Budget, a copy of which is appended hereto as Exhibit A;

SECTION 2 That the Budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's Budget for the fiscal year beginning October 1, 2020, and ending September 30, 2021.

SECTION 3 That there is hereby appropriated the amount shown in said budget necessary to provide for a sinking fund for the payment of the principal and interest and the retirement of the bonded debt requirements of Fiscal Year 2020-2021 of the City of Sullivan City.
